

## The Georgia Paint Horse Club Stallion Service Auction Breeding Agreement

This breeding will sell under the terms expressed in the stallion owner's current service contract, except when in contradiction with that of GPHC Agreement. In that case, the GPHC-SSA contract will take precedence.

Witnesseth:

In consideration of one dollar and other good and valuable considerations, we the owner of the APHA # \_\_\_\_\_ AQHA # \_\_\_\_\_ Stallion \_\_\_\_\_, agree to sell, transfer, and assign the GPHC-SSA one breeding service for the year \_\_\_\_\_, to the above named stallion. It is understood by all parties that this breeding service is assignable only by the GPHC-SSA pursuant to the terms and conditions of its annual Stallion Service Auction for the year in which said breeding applies. The Stallion will remain in the GPHC-SSA until horse is removed by being sold, death, or owner calls and has horse removed. All parties to this agreement are bound and agree to all of the following terms and conditions:

1. That the breeding season for this contract is Feb 1<sup>st</sup> through July 1<sup>st</sup>, and the mare owner shall be entitled to one return privilege the following year for the same mare. If said mare does not produce a live foal that stands and sucks in the year following the first breeding, or in the event of the death, or a vet certified breeding unsoundness, to said mare, a substitute may be used.
2. That should the above named Stallion die or become unfit for service. The said mare has not been serviced, that any money paid by the mare owner to the GPHC-SSA, shall upon verification of the above named stallion owner, be given credit to purchase another stallion fee in the succeeding auction.
3. That stallion owner will not be responsible for any disease, accident, sickness or death of mare or foal, and mare owner will not be responsible for any disease, accident, sickness, or death of the said stallion.
4. Mares must be halter broken.
5. Board will be charged to mare owner by stallion owner in accordance with the normally prescribed board rates. Mare owner will be responsible to pay chute fee to stallion owner if any.
6. Stallion owner shall diligently try to settle mare, and shall have absolute discretion to determine the best way to breed each mare, including the right to retain a licensed veterinarian to assist. Any vet expenses incurred will be paid by the mare owner.
7. A Breeders Certificate will be furnished to mare owner upon all payment of all board and vet expenses owed, or upon birth of a live foal.
8. Breeding will sell under the terms and conditions of current breeding contract. The GPHC-SSA acts only as agent in the sale and will not be responsible for any accident, sickness, or death of any stallion, mare, or foal.
9. The advertised breeding fee for this stallion for the year \_\_\_\_\_, is \$ \_\_\_\_\_, or if the breeding fee is "Private Treaty" or "Does Not Stand to the Public", the following will apply: Using the stallion breeding report from the previous year, the scale shown in the Bylaws will determine the fee. If chute fee applies how much \$ \_\_\_\_\_.
10. Stallion owner is entitled to a free entry for a foal by the above stallion, if service sells.
11. The successful purchaser of the breeding consents to the GPHC-SSA affixing their name to the contract and by presentation of a mare pursuant to a stallion service, which is sold through this program, the mare owner agrees to all terms and conditions herein. The mare owner is entitled to one free entry. The mare owner must pay a membership of GPHC.
12. When the service is sold, the stallion owner will receive one copy of the name of the mare owner inserted, and mare owner will receive one copy. Mare owner acknowledges that delivery of mare for breeding (or receipt of shipped semen) constitutes acceptance of all terms and conditions of this agreement.
